What is the Officials' Licensing Scheme?

This scheme will demonstrate that, as well as holding a recognised qualification, the Official regularly practises on the poolside, and has undertaken education or training to ensure they are up to date with their knowledge of the rules of the sport.

Why do we need to have a Licensing Scheme?

- To assist meet organisers in the selection of Officials
- To provide a summary statement of qualifications and experience
- To help to promote high standards
- To provide a framework for continuous improvement and Continuous Professional Development CPD)
- To provide a vehicle which can be used to implement change
- To commit the holder to uphold the appropriate Home Country Code of Ethics
- To be part of a regulated and developing career structure
- To enable the suspension or removal of the status

Who administers the Scheme?

The Scheme will be administered by the Institute of Swimming (IoS).

What does it cost?

£10 to cover a 4 year accreditation period.

What benefits are there?

- · Photographic identification
- Officials log book
- Extracts of FINA Laws
- Aide-memoire for reporting of infringements of the Rules
- Subsidised CPD opportunities

How to apply for a Licence

The application form must be completed by you, endorsed by the regional organiser and forwarded to the loS, together with the fee and a passport photograph.
