- STAGE 1 TROPHY GALA

Following the January 2013 Stage 1 Trophy Gala, it was apparent that some amendments and clarification on rules were much needed. It was an impossible task for Gala Coordinators to check the swimmers especially with it being a Trophy Gala.

Questions were raised on the Registration of swimmers and the necessity to have dates of birth, Also, how were we going to police the Midland District Qualification times and were they current or past?

Several Clubs had misinterpreted the age groups and the number of swims allowed. Consequently, after much debate, it was decided on the following amendments:- **Stage 1**

If a Swimmer has "ever" achieved a Midland District qualifying time then no participation in this Gala is permitted.

Rule 3: Relays to state 8/9 years only and 10/11 years only

The cannon to read 1 Girl and 1 Boy from each age group with the youngest girl to swim first.

Rule 4: Age Groups 8 years, 9years/under

10years/under 11 years/under

Swimmers may swim a maximum of 3 individual events with 2 events in their own age group

11 years age group may swim 3 individual events.

Rule 5: Only Two Team Managers and Two Lane Coaches shall be appointed by each Club represented.

It was decided to create a Team Sheet to include a disclaimer: - DF would arrange to have this put on the website.

4 LEAGUE RULES

Stage 2:

Rule 3 Cannon will be 8 x 50 meters with 1 Boy and 1 Girl with the youngest Boy swimming first

Rule 4 Age as at date of Final Round

Open Swimmers may swim a maximum of 3 individual events with 2 in own age group

There is No restrictions on the number of relay events a swimmer can swim.

Rule 5 Only Two Team Managers and **a maximum of TWO LANE COACHES** shall be appointed by each Club represented and only these persons shall be allowed on poolside.

Stage 3 Spring:

Rule 3 Cannonwith the youngest Girl swimming first.

Rule 4 Age as at date of Final Round

No restriction on the number of relay events a swimmer can swim

On all Communications it was requested that League Managers details were printed

5. MANAGEMENT BOARD (GALA CO-ORDINATORS)

A request from the Management Board to look again at the current procedures and selection of Gala Co-Ordinators. It had been raised at this committee as it

was felt that the system was not really working.

R.C stated that Gala Co-Ordinators should only have this one task and their role should include overseeing Recorders, Door Money, Checking teams and ensuring everyone in place until Referee takes control.

A.M added that e felt that only 50% of appointments were true Co-Ordinators.

It was proposed that members from SLMC could be set up, but this was debated and thought not viable

A panel of Co-Ordinators to select from was another idea.

I.N. suggested that the two Clubs nominated to host were very often scratching around for Officials, so could a 3rd Host club be nominated purely to provide the Gala Coordinator.? The possibility of this working was debated and received favorable with a unanimous vote.

Note: Subject to ratification by the Management Board.

Alex, Bernie and Roy agreed to set up a Gala Coordinators Course at Potters - Date to be arranged.
